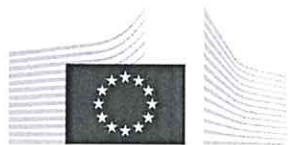

## INFORMATION TO THE PERMANENT REPRESENTATIONS

**Subject: Adaptation of allowances paid to seconded national experts**

Your Excellency,

The Commission decision C(2008) 6866 of 12.11.2008 laying down rules on the secondment to the Commission of national experts and national experts in professional training specifies in article 17(5) that an update of the remuneration under Article 65 of the Staff Regulations shall apply automatically to the subsistence allowances in the month following the update.

Pursuant to Article 65(2) and Article 4(1) of Annex XI of the Staff Regulations, the remuneration and pensions of officials and other agents will be updated with 2,40% in June<sup>1</sup>.

I therefore inform you that the amount of the allowances to be paid by the Commission to seconded national experts according to Article 17(1) of this Decision has been adjusted **as from 1 July 2022** as follows:

- a) Daily allowance: **150,58 €**
- b) Monthly allowance taking into account the distance between the place of origin and place of secondment:

| > 150   | 96,79 €     |
| > 300   | 172,06 €    |
| > 500   | 279,63 €    |
| > 800   | 451,71 €    |
| > 1300  | 709,83 €    |
| > 2000  | 849,67 €    |

The adjustment of the correction coefficients applied to the subsistence allowances for seconded national experts seconded to an EU Member State other than Belgium or Luxemburg will also be applied as from 1 July 2022.

The concerned seconded national experts will receive the new amounts as from July 2022.
